Update on the execution of the buy-back programme

Padua, July 22nd, 2019 – SIT S.p.a. (“SIT”, or the “Company”), listed on the MTA market, with reference to the buy-back programme approved by the shareholders on April 24th 2019, and launched on the same date, informs that in the period between July 15th, 2019, and July 19th, 2019, acquired no. 800 SIT’s ordinary shares at an average unit price of EUR 7,9969 per share, for a total amount of EUR 6.397,49.
